As applications become increasingly web-based, the client browser becomes the primary platform for delivering information, and an attractive target for attack.

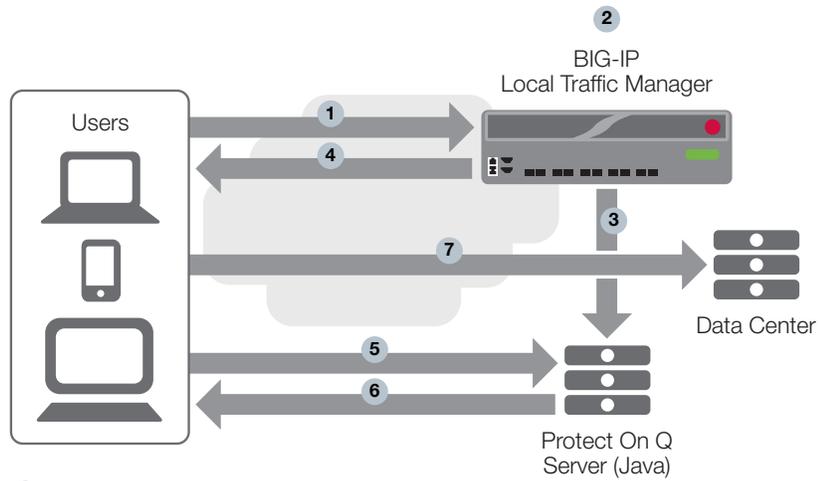

POQ can interact with BIG-IP LTM using the F5 iRules® control language, instructing it to redirect clients to the POQ server before they can access the protected web application through a secure connection. With BIG-IP LTM and POQ, organizations can secure all client browsers, and shield sensitive data from key loggers, frame grabbers, session hijacking, cache miners, and other malware, as well as prevent end users from copying, saving, printing, or screen-capturing browser-delivered data.
